READ BEFORE SIGNING

- If your tax deferral account was paid out and closed, you must submit a new application to your property tax office.
• You can cancel or withdraw your renewal application before it has been approved by the Tax Deferral Program Office; however, you will be charged penalties by your property tax office if this is done after the tax due date.
• A \$10.00 renewal fee, which does not accrue interest, will be added to your account. This does not apply to the Families with Children Property Tax Deferral Program.
• Some applications may take several months to process.
• You must submit your renewal application by December 31 of the current tax year.
